The property briefly comprises: Secure entrance with intercom and stairs to the first floor. Initially the hallway has two useful storage cupboards and doors to the following rooms. A well proportioned living room with heating and point for t.v. Fitted kitchen having matching wall and base units, inset sink, gas hob with steel extractor above and built-in oven below, plumbing for a washing machine and space for an upright fridge/freezer. The main bedroom of some 13ft long has ample space for furniture and wardrobes, bedroom two is a good-sized single room, both looking out to the rear of the building. The three-piece bathroom has a shower over the bath, an inset shelf to the tiled walls, a w.c. sink and towel rail.

Outside there are communal gardens, a dedicated parking space, plus some visitors parking.

The property also benefits from gas central heating to radiators and double glazing.

The location is close to a local shop and a post office, a pub restaurant, open countryside and direct bus routes, as well as near to excellent commuter links across the region.
