Location

Halesowen lies approximately 7 miles from Birmingham City Centre and is just minutes away from junction 3 of the M5 motorway giving access to the greater motorway network all around the West Midlands. The History of Halesowen stems back as far as the Anglo Saxons and it was listed in the Domesday Book as being larger than Birmingham. It forms part of the southern edge of the Black Country and during the industrial revolution it became synonymous with nail and screw making, an industry that still survives to a lesser extent today. Despite its proximity to the Black Country it still retains areas of beauty and Grade I listed Leasowes Park is thought to be one of the first natural landscape gardens in England. In certain areas the town is predominated by a vast array of Victorian houses but further development during the 1960's and 70's saw the building of several large housing estates. It has a number of highly sought after primary and secondary schools. Whilst Halesowen no longer has a train station of its own the Worcester to Birmingham line passes along the northern edge of its boundary and the stations of Cradley Heath, Old Hill and Rowley Regis are all within a few miles of the town centre. Halesowen bus station is a busy interchange and regular service runs to Birmingham City Centre.





Approach

Via street parking stepping up into:

Reception room one 12'1" max 11'1" min x 12'1" (3.7 max 3.4 min x 3.7)

Double glazed bay window to front, electric feature fire, central heating radiator.

Reception room two 10'9" min 11'9" max x 11'9" (3.3 min 3.6 max x 3.6)

Double glazed window to rear, electric fire, central heating radiator.

Inner hallway

Double glazed window to side and access to side.

Kitchen 8'2" x 8'6" (2.5 x 2.6)

Double glazed window to side, combination boiler, tiled flooring and splashbacks, range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, space for washing machine.

Bathroom

Tiled flooring and splashbacks, double glazed window to rear, low level .w.c, wash hand basin with mixer tap over, bath with mixer tap and shower over, central heating radiator.

First floor landing

Central heating radiator and doors radiating to:

Bedroom one 14'5" min 15'8" max x 12'1" (4.4 min 4.8 max x 3.7)

With central heating radiator, double glazed window to front and cupboard off.

Bedroom two 11'9" x 10'9" min 11'9" max (3.6 x 3.3 min 3.6 max)

Double glazed window to rear, central heating radiator.

Rear garden

Slabbed pathway and patio area leading to lawn with beds housing various plants and shrubs, timber fencing and brick wall to enclose.
